


Village Walk at Montgomery

Site Description

- Redevelopment of Village Shopper Shopping Center to a mixed-use development consisting of approximately 52 residential
 units and approximately 54,000 SF of retail as well as being adjacent to The Village Shoppes, a 38,000 SF project by the
 same developer
- The retail will adjoin new residential developments with approximately 365 single-family homes, townhomes, condominiums and active-adult homes behind the project that will have access via a shared roadway
- Located in the heart of Montgomery Township's Master Plan for the redevelopment of the "Downtown" shopping district, the site is situated along Route 206, the main thoroughfare for southern Somerset townships, leading into downtown Princeton a few miles to the south
- Situated at a signalized intersection with Montgomery Center, a ShopRite anchored center
- The project will also have access to a shared traffic signal on Route 518







